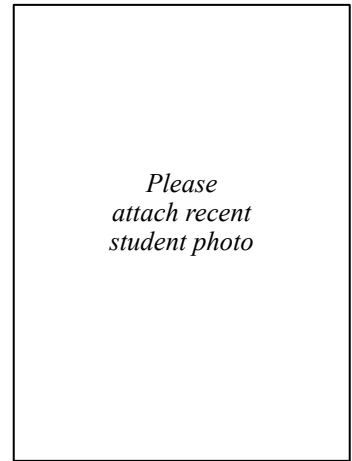

## PARENT/SCHOOL AGREEMENT

In signing this application, I (we):

1. Have answered the questions in this application to the best of my/our knowledge and ability
2. Agree with the school's purpose, as well as its educational and spiritual objectives
3. Are committed to providing a quality, Christian education for our child and in accordance with existing law
4. Are active members of a local, Christian church that is in keeping with the academy's Statement of Faith
5. Are willing to fulfill any parent/family resource requirements
6. Agree with, and are supportive of, the school's procedures for handling student discipline
7. Are willing to provide continually updated immunization records for our student
8. Are willing to have our student's picture in the school's yearbook
9. Are willing to have our family's name, phone number, and address listed in the academy directory which will also be available in a member's only section of the academy's website
10. Acknowledge that we have read and understand the academy handbook
11. Agree to work through a Christian conciliation process should a dispute or situation arise out of any school relationship, as the parties to this agreement are Christians and believe that the Bible commands them to make every effort to live at peace and to resolve disputes with each other in private or within the Christian community in conformity with the biblical injunctions of 1 Corinthians 6:1-8, Matthew 5:23-34, and Matthew 18:15-20. Therefore, the parties agree that any claim or dispute arising out of, or related to, this agreement or to any aspect of the employment relationship, including statutory claims, shall be settled by biblically-based mediation. If resolution of the dispute and reconciliation do not result from mediation, the matter shall then be submitted to a panel of three independent and objective arbitrators for binding arbitration. Each party to the agreement shall have the right to select one arbitrator (unless the parties mutually agree to the use of only one arbitrator). The two arbitrators selected by the parties shall jointly select the neutral, third arbitrator. If there is an impasse in the selection of the third arbitrator, the Institute for Christian Conciliation division of Peacemaker Ministries of Billings, Montana [(406) 256-1583] shall be asked to provide the name of a qualified person who will serve in that capacity. The mediation and arbitration process shall be conducted in accordance with the "Rules of Procedure for Christian Conciliation" contained in the Peacemaker Ministries booklet, Guidelines for Christian Conciliation. The parties agree that these methods shall be the sole remedy for any controversy or claim arising out of an employment relationship or this agreement and expressly waive their right to file a lawsuit against one another in any civil court for such disputes, except to enforce a legally binding arbitration decision.
